Perfect for cocktail hour, engagements, corporate functions, brand activations, birthdays, hen's days...the possibilities are endless!

- 2 Charcuterie - mild salami + prosciutto

- Plus fruit paste/honey pots and bamboo grazing boats

DIETARY REQUIREMENTS

- Yes we can cater for dietary requirements, however, although we take the utmost care in our preparations, we are not a nut free, vegan or gluten free registered kitchen so trace elements may occur. We urge all customers with dietary requirements to take this into consideration and decide if consumption is right for them. Pumpkin and Sage will not be held accountable due to the advisement that our kitchen is not specially registered for dietary requirements.
- Notification of any dietary requirement **MUST** be received in writing at least 7 days prior to the event date. If less notice is provided, we will make all reasonable efforts to accommodate the request but will advise in writing should this not be possible.
- Pumpkin and Sage will not be held accountable for any dietary requirements made known on the day of or during the event.
- Individual grazing boxes can be organised upon request - \$20pp

BOOKING AND PAYMENT TERMS :

- a 50% deposit is required to confirm your booking with the balance payable 14 days prior to your event.
- Payment must be received within 72 hours once invoice has been issued otherwise your date cannot be guaranteed.
- Quotes/ initial invoices are valid for 30 days only and will not be subject to any discretionary price changes during that time.
- Payments accepted are bank transfer or card. All card transactions incur a 1.75% surcharge via Square payments.
- A travel fee of .80c per km may be applicable where events are more than 30kms from our base in Sunbury. If applicable, this will be communicated in your invoice.

CANCELLATIONS & REFUNDS

- Where a change of mind has occurred in regards to our services, a refund cannot be provided.
- Any cancellation 30 days or greater will be refunded in full or provided the option of a credit for another date within the next 6-12 months. Cancellations less than 30 days but greater than 14, will be provided the option of a full refund minus a 25% administration fee or a credit for another date. Cancellations 14 days or less but greater than 7 will forfeit their 50% deposit. A credit will only be offered if another date is to be rescheduled. Cancellations less than 7 days will not be eligible for a refund to cover the cost of goods, labour and loss of business.
- All refunds requested outside of the above conditions outlined will be considered at the discretion of Pumpkin and Sage.



DAMAGES

- All equipment, decor, utensils and anything else provided by Pumpkin and Sage for your event is strictly on loan only and must be returned in the condition in which it was received. Should any damage or loss occur during your event arising from negligence or misuse on your behalf will be billed to you directly for replacement or repair.

ACCEPTANCE OF TERMS & CONDITIONS
